JOINT RESOLUTION 13-04-05-10

A JOINT RESOLUTION IN SUPPORT OF A MEMORANDUM OF UNDERSTANDING WITH THE BUREAU OF INDIAN AFFAIRS MIDWEST REGIONAL OFFICE (BIA MRO) TO REPROGRAM TRIBAL PRIORITY ALLOCATION (TPA) FUNDS FOR THE DIVISION OF FEETO-TRUST PROGRAM

- WHEREAS, the Mille Lacs Band of Ojibwe Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Chief Executive and the Band Assembly of the Mille Lacs Band of Ojibwe have consistently recognized that the greatest single obstacle to the full function and exercise of tribal sovereignty is the continuing inability of the Band to put land into trust; and
- WHEREAS, a continuing source of this difficulty is the under-financing and staffing of Realty operations, specifically concerning fee to trust applications at the BIA MRO in addition to the current backlog of pending fee to trust applications with new applications continually being added; and
- WHEREAS, the BIA has a responsibility to the Band to assist in the fee to trust process, as delineated in 25 C.F.R. 151, including performance of inherently federal functions that cannot be transferred to the Band under P.L. 93-638 Titles I and IV; and
- WHEREAS, the Band wishes to promote the acquisition of certain tribal fee lands into trust status with the United States of America; and
- WHEREAS, the Band is currently participating in the Division of Fee to Trust (Division) and has been able to process the Fee to Trust acquisitions more efficiently; and
- WHEREAS, the Band understands that the current Memorandum of Understanding between the Division and the Band will end on September 30, 2010; and
- WHEREAS, the Band wishes to enter into another Memorandum of Understanding with the Division starting on October 1, 2010 and ending September 30, 2013; and
- WHEREAS, the Band understands that reallocation of TPA funds will be needed for participation in the Division.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 3rd of November, 2009 at Vineland, Minnesota by a vote of <u>3</u> FOR, <u>0</u> AGAINST, <u>0</u> SILENT.
