**RESOLUTION 13-04-22-10**

**A RESOLUTION TO CANCEL LEASE AUTHORIZED BY RESOLUTION #10-04-77-03 FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #10-04-77-03, authorized a lease to be given to [REDACTED] for the purpose of obtaining a lease site; and

WHEREAS, the land use agreement was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:  
That part of Tract # 410 TF 200 located in the Northwest one quarter (NW ¼) of the Southwest one quarter (SW ¼) of Section six (6), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota more particularly described as follows:

Lots 27 and 30 of Block 9, Port Mille Lacs Golf Acres North, recorded plat, lease site is approximately 1 acre more or less.

WHEREAS, [REDACTED] is in violation of lease provisions #3 Construction and Maintenance of Improvements, #17 Purpose and #18 Care of Premises; and

WHEREAS, Notice was given to [REDACTED] to cure provision violations in September 2009; and

WHEREAS, [REDACTED] has not cured provision violations as of December 22, 2009.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the cancellation of lease #410980328 authorized by Band Resolution #10-04-77-03; and


