JOINT RESOLUTION 14-01-134-10

A JOINT RESOLUTION AMENDING THE PROVISIONS OF THE NET GAMING REVENUE ALLOCATION PLAN PROVIDING FOR THE DISTRIBUTION OF PER CAPITA PAYMENTS

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body for the Mille Lacs Band of Ojibwe, a federally recognized Indian tribe; and
- WHEREAS, the Chief Executive is the duly elected Executive Officer for the Mille Lacs Band of Oiibwe and is empowered to exercise the Executive Branch powers; and
- WHEREAS, the Band Assembly is the body referred to in the MCT Constitution as the Reservation Business Committee, as established by 3 MLBSA § 1; and
- WHEREAS, together the Chief Executive and the Band Assembly form the Joint Session, as established by 3 MLBSA § 24; and
- WHEREAS, it is a priority of the Band Assembly and Chief Executive to provide for the general welfare of the eligible and enrolled members of the Mille Lacs Band of Ojibwe; and
- WHEREAS, by Joint Resolution No. 11-04-110-05, the Chief Executive and Band Assembly approved an amendment to the Net Revenue Allocation Plan ("RAP") on September 6, 2005; and
- WHEREAS, on November 6, 2006, the Chief Executive and Band Assembly approved an amendment to the Net Revenue Allocation Plan ("RAP") by Joint Resolution No. 12-02-12-07; and
- WHEREAS, pursuant to 25 U.S.C. § 2710 et seq., Secretarial approval is required for the distribution of casino revenues to Band Members; and
- WHEREAS, at this time, the Band Assembly and Chief Executive believe it is in the best interest of the Band Members to amend the Net Revenue Allocation Plan ("RAP") to adjust the percentages so as to distribute an increased per capita to all adult Band Members while continuing to provide for minor Band Members so as to encourage continuing education through incentives.
