JOINT RESOLUTION 14-01-127-10

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A GRANT APPLICATION TO THE U.S. DEPARTMENT OF INTERIOR: BUREAU OF INDIAN AFFAIRS (DOI:BIA), ENERGY AND MINERAL RESOURCES BUREAU TO ASSIST IN THE FUNDING OF THE MILLE LACS BAND OF OJIBWE

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive have also established as a priority the implementation of renewable energy sources to improve the economic conditions of life for the people of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive are willing to consider development of any potential energy or mineral resource newly discovered; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive are willing to consider the public release of information obtained from the energy and mineral development study; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive are willing to consider working in conjunction with the DOI:BIA Energy and Mineral Resources Bureau in conducting the study and implementation of the renewable energy and mineral project; and

WHEREAS, the Mille Lacs Band of Ojibwe fully supports environmental studies that expands the knowledge base through which tribes can develop renewable energy sources.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby authorize and approve the submission of a grant to the Department of the Interior: Bureau of Indian Affairs for the purpose of creating renewable energy sources on the Mille Lacs Band of Ojibwe reservation.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29th day of June, 2010 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
