RESOLUTION 13-04-24-10

A RESOLUTION RESCINDING RESOLUTION # 05-01-43-92 AUTHORIZING A RESIDENTIAL LAND LEASE TO

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and
- WHEREAS, Resolution #05-01-43-92 authorized a residential land lease to be given to
- WHEREAS, the residential lease was to be for a period of 25 years and renewable for an additional 25 years, effective upon date of approval; and
- WHEREAS, said land is described as follows:

Part of Tract 410 TF 106 located in Section Seven (07), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota.

More particularly described as Follows: Block 17, Lots 21 & 20, Golf Acres North (Plat) in Port Mille Lacs Subdivision, containing I acre more or less; and

- WHEREAS, rescinding Resolution #05-01-43-92 is being requested due to non-use of the site; and
- WHEREAS, resolution #05-01-43-92 granted a lease in 1992 on land which was not acquired by the band until 1995.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the Rescinding of Band Resolution #05-01-43-92; and

BE IT FURTHER RESOLVED, the land will revert to the Mille Lacs Band of Ojibwe.
