**RESOLUTION 14-03-14-11**

**A RESOLUTION MODIFYING RESOLUTION # 12-03-80-07 WHICH  
AUTHORIZED A LAND LEASE FOR RESIDENTIAL PURPOSES TO**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution # 12-03-80-07 authorized a land lease to [REDACTED] for the purpose of establishing a home site; and

WHEREAS, the lease is for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective July 2, 2007 for the property described herein; and

WHEREAS, [REDACTED] is requesting her name be removed from Resolution #12-03-80-07 and lease # 4103100732; and

WHEREAS, Land description is described as follows:  
Part of Tract 410 T 1002 located in Section Twenty-eight (28), Township Forty-three North (T43N), Range Twenty-seven West (R27W), Fourth Principal Meridian, Mille Lacs County, Minnesota.

More particularly described as Follows: Block One (1), Lot Sixteen (16), Vineland Hills, Kathio Township. This lease site is 1 acre more or less.

WHEREAS, removal of [REDACTED] name from Resolution # 12-03-80-07 and lease #4103100732 is being requested based on the Order of Probate for [REDACTED] giving sole ownership of the leasehold interest to [REDACTED] and

WHEREAS, the Order of Probate for [REDACTED] sent by the Mille Lacs Band Tribal Court is attached as Exhibit A as a part of this resolution.
