JOINT RESOLUTION 14-03-38-11

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A MINNESOTA COMMUNITY ACTION GRANT APPLICATION TO THE MINNESOTA DEPARTMENT OF HUMAN SERVICES: OFFICE OF ECONOMIC OPPORTUNITY TO SUPPORT EXISTING PERSONNEL SALARIES FOR THE MILLE LACS BAND OF OJIBWE BOYS AND GIRLS CLUBS

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Mille Lacs Band Assembly recognizes the importance of providing positive mentorship to American Indian children; and

WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of Minnesota DHS: Office of Economic Opportunity to reduce the impacts of poverty on Minnesota families.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do hereby approves the submission of a grant to Minnesota DHS for the purpose of providing positive and responsible mentorship to the Mille Lacs Band youth.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 4th day of May, 2011 at East Lake, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
