RESOLUTION 14-02-04-11

**A RESOLUTION RESCINDING RESOLUTION # 12-04-98-07
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED
SECTION 184 HOUSING LOAN TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #12-04-98-07, authorized a land lease for residential purposes to be given to [REDACTED] for establishing her home with financing obtained from a Section 184 housing loan; and

WHEREAS, the residential lease was to be for a period of 30 years and renewable for an additional 20 years, and is subject to the lease provisions, effective July 26, 2007; and

WHEREAS, said land is described as follows:

Part of Tract 410 TF 134 located in Government Lot Seven (7), Section Eighteen (18), Township Forty-two North (T42N), Range Twenty-six West (R26W), Fourth Principal Meridian, Mille Lacs County, Minnesota.

More particularly described as follows:

Commencing at a Global Positioning System (GPS) Coordinate (447,340.75;5,107,069.19) thence bearing South 90 degrees 00 minutes 00 seconds West a distance of 200.00 feet; thence North 0 degrees 00 minutes 00 seconds East a distance of 200.00 feet; thence North 90 degrees 00 minutes 00 seconds East a distance of 200.00 feet; thence South 0 degrees 00 minutes 00 seconds East a distance of 200.00 feet to the point of beginning (GPS Coordinates are Universal Transverse Mercator (UTM) Zone 15 NAD 83 Projection Points). The lease site is 1 acre more or less.

WHEREAS, rescinding Resolution #12-04-98-07 is being requested due to none use.


