JOINT RESOLUTION 14-03-23-11

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A NATIVE AMERICAN/NATIVE HAWAIIAN MUSEUM SERVICES GRANT APPLICATION TO THE INSTITUTE OF MUSEUM AND LIBRARY SERVICES FOR THE PURPOSES OF CONVERTING EXISTING COLLECTIONS INTO DOCUMENTARY FORMAT

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognizes the importance of educating the people of Mille Lacs Band and the public of Mille Lacs Band history; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the Institute of Museum and Library Services of connecting people to ideas and information.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby authorize and approve the submission of a proposal to the Institute of Museum and Library Services for a Native American/Native Hawaiian Museum Services Grant

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29th day of March, 2011 at East Lake, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.


