## **JOINT RESOLUTION 14-03-38-11**

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A MINNESOTA COMMUNITY ACTION GRANT APPLICATION TO THE MINNESOTA DEPARTMENT OF HUMAN SERVICES: OFFICE OF ECONOMIC OPPORTUNITY TO SUPPORT EXISTING PERSONNEL SALARIES FOR THE MILLE LACS BAND OF OJIBWE BOYS AND GIRLS CLUBS

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly recognizes the importance of providing positive mentorship to American Indian children; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of Minnesota DHS: Office of Economic Opportunity to reduce the impacts of poverty on Minnesota families.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do hereby approves the submission of a grant to Minnesota DHS for the purpose of providing positive and responsible mentorship to the Mille Lacs Band youth.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 4th day of May, 2011 at East Lake, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
