**RESOLUTION 14-02-09-11**

**A RESOLUTION APPROVING THE CONTINUANCE OF THE GAMING REGULATORY AUTHORITY, HOUSING INITIATIVE AND THE CORPORATE COMMISSION FISCAL OPERATIONS UNTIL NOVEMBER 30, 2010.**

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and


WHEREAS, 3 MLBSA § 18 states that in such circumstances, when an appropriation bill will expire before the next such appropriation bill becomes law, that all fiscal operations under the jurisdiction of the Mille Lacs Band shall ease as of midnight of the last day of the fiscal year unless the Band Assembly adopts a continuing resolution to continue any of the Band's fiscal operations; and

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorizes the continuance of the Gaming Regulatory Authority, Housing Initiative and the Corporate Commission fiscal operations until November 30, 2010.
