JOINT RESOLUTION 14-03-29-11

A JOINT RESOLUTION IN SUPPORT OF THE APPOINTMENT OF MIKE MOILANEN TO THE INDIAN RESERVATION ROAD COORDINATING COMMITTEE.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt WHEREAS, resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Indian Reservation Roads Program Coordinating Committee requires a resolution from the Mille Lacs Band of Ojibwe demonstrating its support of the appointment of a representative to the Committee; and
- WHEREAS. the Mille Lacs Band Assembly and Chief Executive recognize the need to have representation on the Indian Reservation Roads Program Coordinating Committee; and
- WHEREAS the Mille Lacs Band Assembly and Chief Executive hereby appoint Mike Moilanen, MLBO Community Development Planner, as the representative given authority to attend and participate in all Indian Reservation Roads Program Coordinating Committee meetings on behalf on the Mille Lacs Band of Oijbwe.
- NOW THEREFORE, BE RESOLVED, that the Mille Lacs Band Assembly and Chief Executive hereby appoint Mike Moilanen to sit on the Indian Reservation Roads Program Coordinating Committee for a 3-year term beginning 2011.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 24th day of March, 2011 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
