A JOINT RESOLUTION APPROVING THE SUBMISSION OF A GRANT APPLICATION FOR THE CIRCLES OF CARE V: INFRASTRUCTURE DEVELOPMENT FOR CHILDREN'S MENTAL HEALTH SYSTEMS TO THE US DEPARTMENT OF HEALTH AND HUMAN SERVICES: SUBSTANCE ABUSE AND MENTAL HEALTH SERVICES ADMINISTRATION GRANT APPLICATION FOR THE PURPOSES OF DEVELOPING A MENTAL HEALTH **SYSTEM OF CARE**

- WHEREAS. the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of educational, social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- the Mille Lacs Band Assembly recognizes the importance of holistic mental WHEREAS, services; and
- the Mille Lacs Band Assembly and Chief Executive fully supports the initiative to WHEREAS. implement a system of care which utilizes all aspects mental well-being for its community members; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive also fully supports the Substance Abuse and Mental Health Administration's mission to reduce the impact of substance abuse and mental illness on America's communities.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do hereby support a submission of a grant application to the Substance Abuse and Mental Health Services Administration for the purposes of developing a mental health system of care.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 24th day of May, 2011 at East Lake, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
