## JOINT RESOLUTION 14-03-25-11

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A SOCIAL AND ECONOMIC DEVELOPMENT STRATEGIES GRANT APPLICATION TO THE ADMINISTRATION FOR CHILDREN AND FAMILIES: ADMINISTRATION FOR NATIVE AMERICANS FOR THE PURPOSES OF FUNDING FINANCIAL LITERACY AND ENTREPRENEURIAL PROGRAMMING FOR THE MILLE LACS BAND YOUTH

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- the Mille Lacs Band Assembly and Chief Executive have established as a priority WHEREAS. the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- the Mille Lacs Band Assembly recognize the importance of empowering its youth WHEREAS, through financial literacy training and entrepreneurial driven curriculum; and
- the Mille Lacs Band of Ojibwe fully support the goals of the Administration for WHEREAS, Native Americans to promote social and economic self sufficiency for American Indians.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby authorize and approve the submission of a Social and Economic Development Strategies proposal to the Administration for Native Americans.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29th day of March, 2011 at East Lake, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
