RESOLUTION 14-03-12-11

A RESOLUTION AUTHORIZING A BUSINESS LEASE TO CORPORATE COMMISSION OF THE MILLE LACS BAND FOR A CONVENIENCE STORE IN LAKE LENA.

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal leases are required for the purposes of a homesite, agricultural and seasonal recreational residence, any commercial activity or acquiring financing for a home on all tribal lands of the Mille Lacs Reservation; and
- WHEREAS, the lease will be for a period of 5 years and renewable for an additional 5 years subject to the lease provisions, effective upon date of approval, for the purpose of commercial development to be located on the property described herein; and
- said land is described as follows: WHEREAS. <u>Tract # 410 TF 80</u>, Located within Township Forty-one North (T41N), Range Seventeen West (R17W), Section Twenty-seven (27) West, Fourth Principal Meridian, Pine County, Minnesota, Approximately 6.0 acres, more or less
- WHEREAS, the annual business lease rental fee is to represent the greater of the amount of property taxes assessed for the property for the previous year or 2% of net income after income taxes for the previous calendar year of the business operating under the terms of this lease.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby Approves a lease to be issued to the Corporate Commission, for a period of 5 years and renewable for an additional 5 years subject to the lease provisions, effective upon date of approval; and
- BE IT FURTHER RESOLVED, that the lessee will utilize the land in conformity with the provisions of the lease within twelve (12) months of the effective date of the lease, and if all terms of the lease are not met, the land will revert to the Mille Lacs Band of Ojibwe; and
- BE IT FURTHER AND FINALLY RESOVLED, that this lease shall be null and void should the lessee abandon or vacate the above-described property for more than thirty (30) consecutive days after the 1st year anniversary of the effective date of the lease without the prior approval of the Band Assembly.
