JOINT RESOLUTION 14-03-26-11

A JOINT RESOLUTION COMMITTING A 20 PERCENT CASH MATCH FOR THE ECONOMIC DEVELOPMENT STRATEGIES GRANT AWARD, IF FUNDED, PROVIDED BY ADMINISTRATION FOR CHILDREN AND FAMILIES: ADMINISTRATION FOR NATIVE AMERICANS FOR THE PURPOSES OF FUNDING FINANCIAL LITERACY AND ENTREPRENERIAL PROGRAMMING FOR THE MILLE LACS BAND YOUTH

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognize the importance of empowering its youth through financial literacy training and entrepreneurial driven curriculum; and

WHEREAS, the Mille Lacs Band of Ojibwe fully support the goals of the Administration for Native Americans to promote social and economic self sufficiency for American Indians.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive does hereby authorize and approve the commitment of a 20 percent cash match for the Social and Economic Development Strategies grant award by the Administration for Native Americans.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29th day of March, 2011 at East Lake, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
