JOINT RESOLUTION 14-03-10-11

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A PROTECTING HISTORIC PROPERTIES AND CULTURAL TRADITIONS ON INDIAN LANDS GRANT FROM THE DEPARTMENT OF THE INTERIOR: NATIONAL PARK SERVICE, TRIBAL PRESERVATION PROGRAM TO HELP FUND THE IDENTIFICATION OF CULTURALLY SIGNIFICANT AND SACRED SITES ON THE MILLE LACS INDIAN RESERVATION.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and the Chief Executive has established as a priority to improve the social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the Tribal Preservation

 Program to preserve and protect resources and traditions that are of importance to

 Native Americans.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and the Chief Executive does hereby authorize and approve the submission of a grant to the Department of Interior: National Park Service, Tribal Preservation Program to fund the identification of culturally significant and sacred sites on the Mille Lacs Indian Reservation.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 10th day of February, 2011 at Isle, Minnesota by a vote of <u>2</u> FOR, <u>0</u> AGAINST, <u>0</u> SILENT.
