JOINT RESOLUTION 14-04-65-11

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A TRIBAL WILDLIFE GRANT TO THE US DEPARTMENT OF INTERIOR: FISH AND WILDLIFE SERVICE

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive has established as a priority the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and

WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognize the importance of revitalizing imperiled and declining species; and

WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the US Fish and Wildlife Service to conserve, protect, and enhance fish and wildlife and their habitats.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do hereby authorize and approve the submission of a proposal to US Department of Interior: US Fish and Wildlife Service for the Tribal Wildlife Grant.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 12th day of September, 2011 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
