

JOINT RESOLUTION 14-04-72-11

A JOINT RESOLUTION APPROVING 2011 MEMBERSHIP INTO THE NATIONAL CONGRESS OF AMERICAN INDIANS (NCAI)

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band of Ojibwe wishes to remain a Member Tribe in good standing of the National Congress of American Indians (NCAI); and
- WHEREAS. the Mille Lacs Band of Ojibwe meets all requirements for Tribal Membership pursuant to Article II, Section 1(b) of the Constitution of the National Congress of American Indians.
- NOW, THEREFORE BE IT RESOLVED, that the Mille Lacs Reservation Band Assembly hereby authorizes Marge Anderson, who is the Chief Executive of the Tribe, to take the necessary action to place the Tribe in membership in NCAI; and
- BE IT FURTHER RESOLVED, that tribal funds in the amount of \$25,000.00 based on the Tribal Membership dues schedule of the NCAI by-laws, Article III, Section 1(b), are authorized to be paid for such Tribal Membership in NCAI; and
- BE IT FURTHER RESOLVED, that, based on membership of 4,293 persons, as verified by the records of the Mille Lacs Tribal Enrollments Office, the Tribe shall have 140 votes in accordance with Article IV, Section 3 of the NCAI Constitution; and
- BE IT FURTHER AND FINALLY RESOLVED, that pursuant to Article V, Section 2, of the NCAI Constitution the Tribe designates the following named persons as Delegate and Alternate Delegates, and instructs them to become individual Members in good Standing in NCAI in order to fulfill their responsibilities as Official delegates to the National Congress of American Indians.
