
A JOINT RESOLUTION APPROVING THE TEMPORARY WAIVER OF THE LICENSING REQUIREMENT FOR VENDORS FOR THE 45th ANNUAL TRADITIONAL POWWOW.

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly acting pursuant to 3 MLBSA § 2 has the authority to enact laws which promote the general welfare of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the 2010 Traditional Powwow Committee has experienced a decrease in vendors due to the enforcement of current licensing requirements set forth in 18 MLBSA Chapters 1 and 2; and
- WHEREAS, the Band Assembly and Chief Executive acknowledge that the Annual Traditional Powwow is a traditional and cultural event and that vendors for these events should not be subjected to the licensing requirements of Title 18.
- NOW THEREFORE BE IT RESOLVED, that licensing requirements set forth in Title 18 of Mille Lacs Band Statutes are hereby waived for the vendors of the 45th Annual Traditional Powwow; and

BE IT FURTHER RESOLVED, that this resolution will only be effective until August 23, 2011.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 4th day of August, 2011, at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
