**JOINT RESOLUTION 14-03-54-11**

**A JOINT RESOLUTION APPROVING THE SUBMISSION OF A COMMUNITY  
BASED CHILD ABUSE PREVENTION PROGRAM GRANT TO THE  
ADMINISTRATION FOR CHILDREN AND FAMILIES TO SUPPORT CHILD  
ABUSE PREVENTION EFFORTS OF THE MILLE LACS BAND FAMILY  
SERVICES DEPARTMENT**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and the Chief Executive have established as a priority the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the Administration's goal to reduce occurring and reoccurring child abuse and neglect within Tribal populations.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do hereby authorize and approve the submission of a grant to Administration for Children and Families for the purpose of implementing a community based child abuse prevention program.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 29<sup>th</sup> day of June, 2011 at Isle, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
