JOINT RESOLUTION 15-01-121-12

A JOINT RESOLUTION REQUESTING FUNDS TO IMPLEMENT THE BUREAU OF INDIAN AFFAIRS (BIA) TRIBAL TRANSPORTATION IMPROVEMENT PLAN (TIP) FOR 2012-2015 TO FUND INDIAN RESERVATION ROADS (IRR) PROJECTS

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly acting pursuant to 3 MLBSA § 2 has the authority to enact laws which promote the general welfare of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Chief Executive is empowered to exercise all executive political authority for the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band of Ojibwe, under the provisions of the P.L. 93-638, have contracted to conduct transportation planning activities; and
- WHEREAS, in order to effectively use limited Indian Reservation Road system resources, the Band does hereby provide an updated Tribal Transportation Improvement Plan (TIP) for 2012-2015 (Attachment A) as well as a Tribal Transportation Improvement Plan (TIP).

NOW THEREFORE BE IT RESOLVED, the Mille Lacs Band Assembly and Chief Executive do hereby approve the 2012-2015 Tribal Transportation Improvement Plan (TIP) attached hereto as Attachment A as well as a Tribal Transportation Improvement Plan (TIP).

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 2nd day of May, 2012 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.


