**RESOLUTION 14-04-86-12**

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED  
BY RESOLUTIONS # 44-84, 72-84 & 03-33-85 FOR [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and,

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and,

WHEREAS, Resolutions #44-84, 72-84 & 03-33-85, authorized a lease to be given to [REDACTED] for the purpose of obtaining a leasesite; and,

WHEREAS, the land lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and,

WHEREAS, said land is described as follows:

Part of Tract 410 T 1007 located in the Southeast quarter of the Northwest quarter of Section Twenty-eight (28), Township Forty-three North (43N), Range Twenty-seven West (27W) Mille Lacs County, Fourth Principal Meridian,

More particularly described as follows:

Block 3, sub lot 6, as defined by the Vineland Hills map. This lease site is 1 acre more or less.

WHEREAS, [REDACTED] was relocated to another lease site location by Grand Casino Mille Lacs and no longer resides at the described property above.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby approves the cancellation of the land lease authorized by Band Resolutions #44-84, 72-84 & 03-33-85; and,

BE IT FURTHER RESOLVED, the land will revert to the Mille Lacs Band of Ojibwe.
