JOINT RESOLUTION 15-01-127-12 - Confidential

**A JOINT RESOLUTION RESCINDING JOINT RESOLUTION
15-01-120-12 TO BE IN COMPLIANCE WITH MCT ORDINANCE
NO. 9 REGARDING DISENROLLMENT**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly has recently received and reviewed MCT Ordinance No. 9 dated January, 1983 which approved a disenrollment process; and
- WHEREAS, the Band Assembly previously received information from the Adoptions Department for Human Services and concluded that Tenase Tiessen was erroneously enrolled into the Mille Lacs Band on May 22, 1963; and
- WHEREAS, the information revealed that Tenase Mariastayr Tiessen f/k/a Barbara Jean Martin was born on [REDACTED] to mother, Darlene May Martin, who was not enrolled in the Mille Lacs Band; and
- WHEREAS, Tenase Tiessen f/k/a Barbara Jean Martin was adopted by George Edward Tiessen and Rosealma Tiessen on March 16, 1961 and, even though no parent was enrolled, she was erroneously enrolled in the Mille Lacs Band on May 22, 1963; and
- WHEREAS, the Band Assembly believes that in order to follow MCT Ordinance No. 9 disenrollment process, that Joint Resolution 15-01-120-12 should be rescinded to provide Ms. Tiessen with notice and an opportunity to be heard prior to disenrollment.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly rescinds Joint Resolution 15-01-120-12 to be in compliance with MCT Ordinance No. 9 regarding disenrollment and hereby authorizes that notice and the opportunity to be heard be provided to Ms. Tiessen prior to any action.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 22nd day of May, 2012 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


