JOINT RESOLUTION 15-01-106-12

A JOINT RESOLUTION EXTENDING THE APPROVAL DATE FOR THE LENDING OF THE MLBO LEGISLATIVE BANDOLIER BAG TO THE NATIVE AMERICAN COMMUNITY DEVELOPMENT INSTITUTE (NACDI) FOR AN EXHIBITION OF TRADITIONAL ARTS.

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Band Assembly acknowledges that any piece of traditional art or types of art media purchased with Band funds are the property of the Mille Lacs Band of Ojibwe (MLBO); and
- WHEREAS, by Joint Resolution 14-04-61-11 approved August 4, 2011, the Band agreed to loan a beaded bandolier bag, purchased with Band funds from Band Member Cheryl Benjamin for \$15,000.00 on August 15, 2007, to the Native American Community Development Institute for an exhibition of traditional art; and
- WHEREAS, the Band Assembly acknowledges that this bandolier bag is owned by the Mille Lacs Band of Ojibwe and that it agreed to allow the exhibition of the bandolier bag until June 30, 2012; and
- WHEREAS, Dyani Renyolds-White Hawk, project manager, for the Native American Community Development Institute (NACDI) in Minneapolis, MN is requesting an extension of time as the Tweed Museum of Art, located on the campus of the University of Minnesota Duluth, has extended its exhibition to August 31, 2012; and
- WHEREAS, in order to allow sufficient time to continue the exhibition through the start of the fall semester at the University of Minnesota Duluth and allow ample time to return the bandolier bag to the Legislative Office, the Band Assembly agrees to extend the loan date to September 14, 2012.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly agrees to extend the loan date of the bandolier bag to September 14, 2012 in order to allow the Native American Community Development Institute (NACDI) in Minneapolis, MN to exhibit the Legislative bandolier bag as part of a traveling exhibit showcasing traditional art; and

BE IT FURTHER RESOLVED, that the Mille Lacs Band Assembly agrees to the extension to allow the NACDI to continue to showcase the bandolier bag through September 14, 2012 as part of the exhibit of the Tweed Museum of Art located on the campus of the University of Minnesota Duluth and understands that the bandolier bag shall be returned to the MLBO Legislative Office no later than September 14, 2012.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 7th of February, 2012 at McGregor, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
