RESOLUTION 15-01-110-12

**A RESOLUTION MODIFYING RESOLUTION # 06-01-92-94 WHICH
AUTHORIZED LAND LEASES FOR RESIDENTIAL PURPOSES TO
MILLE LACS RESERVATION HOUSING DEPARTMENT**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution # 06-01-92-94 authorized a land lease to the Mille Lacs Reservation Housing Department for the purpose of establishing home sites; and
- WHEREAS, the lease is for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective May 24, 1994 for the property described herein; and
- WHEREAS, Removal of land description 14 is requested from Resolution #06-01-92-94; and
- WHEREAS, Land description 14 is described as follows:

That part of NE ¼ of NE ¼ of Section 35 Barry Twp. 41N Range 20W. Beginning at the SE corner, thence N. 300', to point of beginning of Lot A, thence West 200', thence North 102', thence South 102' to point of beginning, Pine County, State of Minnesota, containing .047 acres more or less.

- WHEREAS, removal of lease description 14 stated above from Resolution # 06-01-92-94 is due to the fact that a home was never constructed on lease description 14 for the purpose of subleasing to Mary Ann Ailport.
- WHEREAS, lease description 14 is now part of another leasesite.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby Authorizes modification of Resolution # 06-01-92-94, by removing the lease description 14 identified above and all other terms and conditions shall remain the same.


