
**JOINT RESOLUTION 15-01-120-12 - Confidential**

**A JOINT RESOLUTION AUTHORIZING DISENROLLMENT FOR THE FOLLOWING INDIVIDUAL, WHO DOES NOT HAVE A PARENT ENROLLED.**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has reviewed the following information submitted by the enrollment office and is requesting a disenrollment; and
- WHEREAS, information received from the Adoptions Department for Human Services, stating that Tenase Tiessen was actually born as Barbara Jean Martin to Darlene May Martin on [REDACTED]; and
- WHEREAS, Darlene May Martin who was born on [REDACTED], was never enrolled and died on [REDACTED]; and
- WHEREAS, Barbara Jean Martin aka Tenase Tiessen was adopted by George Edward Tiessen and Rosealma Tiessen on March 16, 1961; and
- WHEREAS, Tenase Tiessen was erroneously enrolled May 22, 1963; and
- WHEREAS, Tenase Mariastayr Tiessen aka Barbara Jean Martin should be removed from the rolls of the Mille Lacs Band due to no parent enrolled.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly authorizes the disenrollment of Tenase Tiessen due to no parent enrolled.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 10th, day of May, 2012 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.


