**A RESOLUTION CANCELLING RESOLUTION # 11-04-103-05
AUTHORIZING A RESIDENTIAL LAND LEASE WITH AN ATTACHED
MORTGAGE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home, and

WHEREAS, Resolution #11-04-103-05 authorized a land lease for residential purposes to be given to [REDACTED] for establishing her home with financing obtained from the Mille Lacs Band of Ojibwe Housing Department; and

WHEREAS, the residential lease was to be for a period of 35 years and renewable for an additional 15 years, and is subject to the lease provisions, effective July 21, 2005; and

WHEREAS, said land is described as follows:
Part of Tract 410 T 1001 located in the North one-half (N ½) of the Northeast One-quarter (NE ¼) of Section Twenty (20), Township Forty-three North (T43N) Range Twenty-seven West, (R27W) Mille Lacs County, Fourth Principal Meridian, more particularly described as follows:

Lot Nine (9), Bugg Hill Plat. The lease site is approximately 1 acre more or less; and,

WHEREAS, [REDACTED] is in violation of provisions 6 and 18 of her lease agreement and because she did not notify the Real Estate Department she would be gone from her leased premises for more than 30 days. Please see "Attachment A Lease #4101659540."

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the cancellation of Band Resolution #11-04-103-05; and,

BE IT FURTHER AND FINALLY RESOLVED, the land will revert to the Mille Lacs Band of Ojibwe.
