**JOINT RESOLUTION 14-04-77-12**

**A JOINT RESOLUTION APPROVING THE SUBMISSION OF A FY2012-2013 STATEWIDE HEALTH IMPROVEMENT PROGRAM GRANT APPLICATION TO THE MINNESOTA DEPARTMENT OF HEALTH**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of the spiritual, physical, social, and mental well-being of our Communities; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognizes the importance of reducing and preventing the rates of obesity as a means of addressing the risks of chronic diseases, including diabetes, and containing health care costs; and
- WHEREAS, the Mille Lacs Band of Ojibwe fully supports the goals of the Statewide Health Improvement Program to promote systematic and environmental changes that create Healthy Food Environments and inspire Physical Activity for all members of our community.

NOW, THEREFORE, BE IT RESOLVED that the Mille Lacs Band Assembly and Chief Executive do hereby authorize and approve the submission of a proposal to the Minnesota Department of Health for the FY2012-2013 Statewide Health Improvement Program.

WE DO HEREBY CERTIFY that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 25th day of October, 2011 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
