JOINT RESOLUTION 14-04-95-12

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A FY2012 INDIAN COMMUNITY DEVELOPMENT BLOCK GRANT (ICDBG) TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO FUND THE REHABILITATION OF HOUSING AND TO CREATE ECONOMIC OPPORTUNITIES FOR MILLE LACS BAND MEMBERS.

1.	WHEREAS,	the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian
		Tribe; and

2.	WHEREAS,	according to 3 MLBSA § 2(d), the Band Assembly is empowered
		to adopt resolutions to promote the general welfare of the people of
		the Band; and

3. WHEREAS,	the Chief Executive of the Band is empowered to exercise the
	Executive Branch powers of the Band; and

4.	WHEREAS,	the Mille Lacs Band Assembly and Chief Executive have
		established as a priority the improvement of the spiritual, physical,
		social, and mental well-being of the Band's Communities; and

5.	WHEREAS,	the Mille Lacs Band Assembly and Chief Executive recognize the
		importance of maintaining decent housing, suitable living
		environments, and economic opportunities for persons with low-
		and moderate-incomes; and

6.	WHEREAS,	the Mille Lacs Band Housing Board is a representative body of the
		Community that holds bi-weekly meetings to solicit housing
		concerns and needs from Mille Lacs Band members; and

7.	WHEREAS,	the FY2012 ICDBG application for housing rehabilitation has
		been developed by the Department of Housing in response to the
		community's advocacy for housing rehabilitation services; and

- 8. WHEREAS, if awarded, the Mille Lacs Band of Ojibwe Department of Housing is committed to leveraging up to \$200,000 (the equivalent of 25 percent of the total budget) from its IHBG funds as cost sharing in support of the proposed housing rehabilitation project.
- 9. NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly does hereby authorize and approve the submission of a FY2012 Indian Community Development Block Grant (ICDBG) to the U.S. Department of Housing and Urban Development.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on the 3rd day of January, 2012 at Lake Lena, Minnesota by a vote of _3_FOR, _0_AGAINST, _0_SILENT.
