RESOLUTION 15-01-129-12

**A RESOLUTION RESCINDING RESOLUTION 12-04-117-08, DATED
OCTOBER 23, 2007, WHICH APPROVED THE TEMPORARY WAIVER
OF BONDING REQUIREMENTS ON RESIDENTIAL CONTRACTS
AWARDED TO BAND MEMBER CONTRACTORS**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly acting pursuant to 3 MLBSA section 2 has the authority to enact laws which promote the general welfare of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Band Assembly previously decided that 7 MLBSA sec. 17 which requires that the Band observe industry standards for bonding requirements on all construction contracts awarded for \$50,000.00 or more was prohibitive for some Band member contractors; and
- WHEREAS, the Band Assembly approved Resolution 12-04-117-08 on October 23, 2007 to temporarily waive the bonding requirements for Band member contractors; and
- WHEREAS, at this time, the Band Assembly believes the waiver of the bonding requirement for Band member contractors is no longer needed and believes that it should be rescinded; and
- WHEREAS, hereafter, the bonding requirements for all construction and facility contracts awarded for \$50,000.00 or more shall adhere to industry standards as promulgated in 7 MLBSA sec. 17, including all residential construction projects funded by Band revenue.
- NOW THEREFORE BE IT RESOLVED, that Resolution 12-04-117-08, approving the temporary waiver of bonding requirements for Band Member contractors, is hereby rescinded; and
- BE IT FURTHER RESOLVED, that bonding requirements in contracts for construction and facility improvements awarded for \$50,000.00 or more shall follow industry standards as required by 7 MLBSA sec. 17.
