JOINT RESOLUTION 15-02-165-12

A JOINT RESOLUTION APPROVING THE SUBMISSION OF A FY2013 TRIBAL WILDLIFE GRANT APPLICATION TO THE U.S. DEPARTMENT OF INTERIOR: FISH AND WILDLIFE SERVICE

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of social and economic conditions and quality of life for the people of the Mille Lacs Band of Ojibwe; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognize the importance of enhancing our natural resources by revitalizing imperiled and declining wildlife species; and
- the Mille Lacs Band of Ojibwe fully supports the goals of the U.S. Fish and WHEREAS, Wildlife Service to conserve, protect, and enhance wildlife and their habitats; and
- the Mille Lacs Band Assembly and Chief Executive recognize that cost sharing WHEREAS, funds are not required as a condition to be awarded the Tribal Wildlife Grant.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly and Chief Executive do hereby authorize and approve the submission of a proposal to U.S. Fish and Wildlife Service for the FY2013 Tribal Wildlife Grant.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 9th day of August, 2012 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
