RESOLUTION 14-04-92-12

A RESOLUTION APPROVING THE CONTINUANCE OF THE GOVERNMENT OPERATIONS, GAMING REGULATORY AUTHORITY, HOUSING INITIATIVE, CIRCLE OF HEALTH, DEPARTMENT OF ATHLETIC REGULATION AND THE CORPORATE COMMISSION FISCAL OPERATIONS UNTIL JANUARY 31, 2012.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight of the last day of the fiscal year unless the Band Assembly adopts a continuing resolution prior to such time.
- WHEREAS, Band Assembly Appropriation Bill 13-04-49-09, to fund the operations of the Band Government for fiscal years 2010 and 2011, expires September 30, 2011; and
- WHEREAS, a continuing Resolution 14-03-73-11 expired on November 30, 2011, due to Fiscal Year 2012 budgets have not been approved for Government Operations, Gaming Regulatory Authority, Housing Initiative, Circle of Health, Department of Athletic Regulation and the Corporate Commission; and
- WHEREAS, the Band Assembly adopted a second continuing Resolution 14-04-88-12, which will expire on December 31, 2011; and
- WHEREAS, the Band Assembly feels it necessary to adopt a third continuing Resolution to extending the date to January 31, 2012.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Government Operations, Gaming Regulatory Authority, Housing Initiative, Circle of Health, Department of Athletic Regulation and the Corporate Commission fiscal operations until January 31, 2012.
