**JOINT RESOLUTION 15-02-169-12**

**A JOINT RESOLUTION APPROVING A REQUEST FOR THE RETURN OF TRUST FUNDS FROM THE OFFICE OF THE SPECIAL TRUSTEE (OST) FOR AMERICAN INDIANS- ACCOUNT [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Mille Lacs Band of Ojibwe (MLBO) acknowledges that the Office of the Special Trustee (OST) for American Indians, U.S. Department of the Interior, holds trust accounts representing ineligible per capita funds and/or judgment funds and now requests the return of these funds to the Band; and

WHEREAS, the Mille Lacs Band hereby requests that Account [REDACTED] in the amount of \$7,928.88 identified as ineligible per capita funds be closed and disbursed to the Band; and

WHEREAS, the Mille Lacs Band hereby approves of such request for disbursement to the Band and closure of the above-referenced account.

NOW, THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby approves of the request for closure of Account [REDACTED] in the amount of \$7,928.88 and request that such amount be disbursed to the Band via direct deposit as follows:


