JOINT RESOLUTION 15-01-120-12 - Confidential


A JOINT RESOLUTION AUTHORIZING DISENROLLMENT FOR THE FOLLOWING INDIVIDUAL, WHO DOES NOT HAVE A PARENT ENROLLED.

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Mille Lacs Band Assembly has reviewed the following information submitted by the enrollment office and is requesting a disenrollment; and
- WHEREAS, information received from the Adoptions Department for Human Services, stating that [REDACTED] was actually born as [REDACTED] to [REDACTED] on [REDACTED]; and
- WHEREAS, [REDACTED] who was born on [REDACTED], was never enrolled and died on [REDACTED]; and
- WHEREAS, [REDACTED] was adopted by [REDACTED] and [REDACTED] on March 16, 1961; and
- WHEREAS, [REDACTED] was erroneously enrolled May 22, 1963; and
- WHEREAS, [REDACTED] should be removed from the rolls of the Mille Lacs Band due to no parent enrolled.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly authorizes the disenrollment of [REDACTED] due to no parent enrolled.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 10th, day of May, 2012 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.


