JOINT RESOLUTION 14-04-94-12

**A JOINT RESOLUTION AMENDING JOINT RESOLUTION 14-04-83-12
AUTHORIZING THE ACQUISITION OF UNDIVIDED INTEREST
FROM ██████████ IN ALLOTMENT 410 117 IN TRUST FOR
THE MILLE LACS BAND OF CHIPPEWA INDIANS**

1. WHEREAS, the Mille Lacs Band of Chippewa Indians (Band) is a federally-recognized Indian tribe; and
2. WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Band; and
3. WHEREAS, the Band wishes to acquire undivided interests in allotments located within the exterior boundaries of the Mille Lacs Reservation for the purposes of land consolidation, reduction of fractionation in allotments, and to prevent lands from going out of trust; and
4. WHEREAS, ██████████, a Mille Lacs Band member, wishes to sell his undivided interest of 4500/189000 in Allotment 410 117 for Fair Market Value to the Mille Lacs Band; and
5. WHEREAS, A value of \$30,000 was assigned in an appraisal conducted on Allotment 410 117; and
6. WHEREAS, ██████████ share of the \$30,000 is equal to \$714.29; and
7. WHEREAS, Allotment 410 117 is legally described as the East ½ of the Southeast ¼ of the Southwest ¼ of the Southeast ¼ of Section Seventeen, Township Forty-three North, Range Twenty-seven West, Mille Lacs Reservation, Mille Lacs County, MN, 4th principal meridian.
8. WHEREAS, Joint Resolution 14-04-83-12 was passed on November 8, 2011, with an error on the 6th WHEREAS, showing ██████████ name, instead of ██████████
9. NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band of Chippewa Indians hereby approves the acquisition of the 4500/189000 undivided interest in Allotment 410 117 from Mille Lacs Band Member ██████████ for \$714.29 to the United States of America in trust for the Mille Lacs Band of Chippewa Indians; and

10. BE IT FURTHER AND FINALLY RESOLVED, the Mille Lacs Band of Chippewa Indians hereby approves the 6th WHEREAS to read Clarence Boyd.


