JOINT RESOLUTION 15-03-187-13

A JOINT RESOLUTION APPROVING A PROVISIONAL LICENSE TO OPERATE EARLY HEAD START, HEAD START AND CHILD CARE IN THE MILLE LACS BAND OF OJIBWE NEW CHILD CARE CENTER BUILDING IN DISTRICT I

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and

WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and

WHEREAS, the Band Assembly acknowledges that a statutory amendment regarding the licensing of child care centers on Band Lands in Title 8 is pending; and

WHEREAS, that Joint Resolution 15-02-172-12 was adopted on August 24, 2012 to approve a provisional license to operate the Band's new child care center which opened on Tuesday, August 28, 2012; and

WHEREAS, that Joint Resolution 15-02-172-12 also approved a provisional license to operate Early Head Start and Head Start in the new child care center building beginning on September 4, 2012; and

WHEREAS, the provisional licenses approved by Joint Resolution 15-02-172-12 on August 24, 2012 will expire on February 28, 2013 and a new provisional license is needed until the Band's licensing statute is finalized; and

WHEREAS, the Band Assembly and Chief Executive now approve of a provisional license for a period of four (4) months to allow Early Head Start, Head Start, and the child care center in the new child care center building to operate during this period of time beginning on March 1, 2013.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby approves the provisional license for a period of four (4) months beginning on March 1, 2013 for the operation of a child care center, Early Head Start, and Head Start, in the new child care center building in District I.
