JOINT RESOLUTION 15-03-232-13

A JOINT RESOLUTION APPROVING A PROVISIONAL LICENSE TO OPERATE EARLY HEAD START AND HEAD START IN DISTRICT II AND DISTRICT III

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly acknowledges that a statutory amendment regarding the licensing of child care centers on Band Lands in Title 8 is pending; and
- WHEREAS, that Joint Resolutions 15-02-173-12 and 15-03-188-13 were adopted to approve the operation of Early Head Start and Head Start programs in District II and District III and that this latest provisional license expires on June 30, 2013; and
- WHEREAS, a provisional license for the District II and District III Early Head Start and Head Start program is now needed; and
- WHEREAS, the Band Assembly and Chief Executive now approve of a provisional license to allow the Early Head Start and Head Start programs in District II and District III to operate during this period of time beginning on July 1, 2013 and ending on September 30, 2013, or ending earlier when the statutory amendment is adopted.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby approves the provisional license for the operation of the Early Head Start and Head Start programs in District II and District III beginning on July 1, 2013 and ending on September 30, 2013, or ending earlier when the statutory amendment is adopted.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 13th day of June, 2013 at Hinckley, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


