**RESOLUTION 15-02-08-13**


**A RESOLUTION APPROVING THE CONTINUANCE OF THE CORPORATE COMMISSION FISCAL OPERATIONS UNTIL JANUARY 31, 2013**

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and
- WHEREAS, 3 MLBSA § 18 requires that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight on the last day of the fiscal year unless the Band Assembly adopts a continuing resolution prior to such time.
- WHEREAS, Band Assembly Appropriation Bill 14-04-44-12, to fund the operations of the Corporate Commission for Fiscal Year 2012, expires September 30, 2012; and
- WHEREAS, this continuing Resolution 15-02-178-12 expires on November 30, 2012; and the Band Government has not approved a 2013 Corporate Commission budget; and
- WHEREAS, the Band Assembly agrees to adopt a second continuing resolution until January 31, 2013.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorize the continuance of the Corporate Commission fiscal operations until January 30, 2013.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 20th day of November, 2012 at East Lake, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
