**A JOINT RESOLUTION REQUESTING AN UPDATE OF INDIAN  
RESERVATION ROADS (IRR) LONG RANGE PLAN AND INVENTORY  
FOR FY 2013**

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a Federally-recognized Indian Tribe; and


WHEREAS, the Mille Lacs Band of Ojibwe have contracted under the provisions of P.L. 93-638 to conduct transportation planning activities; and

WHEREAS, in order to effectively use limited Indian Reservation Road system resources.


NOW THEREFORE BE IT RESOLVED that we the Mille Lacs Band Assembly do hereby amend the August 5, 2004 TRANSPORTATION PLAN to add route #189 section 20, route # 211 section 10, route #212 section 10, route #213 section 10, route #214 section 10, route #215 section 10 to the Mille Lacs Band of Ojibwe long range transportation plan and to the Mille Lacs Band of Ojibwe IRR inventory. These sections should be added to provide access to housing on the Mille Lacs Indian Reservation which is important to the general health, medical facilities, and economic development opportunities and welfare of the residents of the Reservation.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 12th of March, 2013 at Hinckley, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
