**JOINT RESOLUTION 15-04-261-13**

**A JOINT RESOLUTION APPROVING A PROVISIONAL LICENSE TO OPERATE EARLY HEAD START AND HEAD START IN DISTRICT II AND DISTRICT III**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly acknowledges that a statutory amendment regarding the licensing of child care centers on Band Lands in Title 8 was recently adopted by the Band Assembly through Bill 15-04-49-13 dated October 1, 2013; and
- WHEREAS, that Joint Resolution 15-03-232-13 was adopted to approve the operation of Early Head Start and Head Start programs in District II and District III and that this latest provisional license expired on September 30, 2013; and
- WHEREAS, a provisional license for the District II and District III Early Head Start and Head Start program is now needed to allow time for the Licensing Committee to form; and
- WHEREAS, the Band Assembly and Chief Executive now approve of a provisional license to allow the Early Head Start and Head Start programs in District II and District III to operate during this period of time beginning on October 1, 2013 and ending on September 30, 2014.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby approves the provisional license for the operation of the Early Head Start and Head Start programs in District II and District III beginning on October 1, 2013 and ending on September 30, 2014.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 1<sup>st</sup> day of October, 2013 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.


