RESOLUTION 15-02-09-12

A RESOLUTION APPROVING THE CONTINUANCE OF HOUSING INITIATIVE FOR FISCAL OPERATIONS UNTIL JANUARY 31, 2013.

WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body for the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly has the authority to appropriate all Band revenue, regardless of source; and

WHEREAS, Appropriation Bill 15-01-52-12, to fund the Housing Initiative for Fiscal Year 2012, expires September 30, 2012; and

WHEREAS, 3 MLBSA § 18 states that in such circumstances, when an appropriation bill will expire before the next such appropriation bill becomes law, that all fiscal operations under the jurisdiction of the Mille Lacs Band shall cease as of midnight of the last day of the fiscal year unless the Band Assembly adopts a continuing resolution to continue any of the Band's fiscal operations.

WHEREAS, this continuing Resolution 15-02-180-12 expires on November 30, 2012; and the Band Government has not approved a 2013 Housing Initiative budget; and

WHEREAS, the Band Assembly agrees to adopt a second continuing resolution until January 31, 2013.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Ojibwe hereby authorizes the continuance of Housing Initiative fiscal operations until January 31, 2013.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 20th day of November, 2012 at East Lake, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
