RESOLUTION 15-04-251-13

**A RESOLUTION RESCINDING RESOLUTION 15-03-223-13
AUTHORIZING A RESIDENTIAL LAND LEASE TO [REDACTED]**

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution 15-03-223-13, authorized a residential land lease to be given to [REDACTED]; and

WHEREAS, the residential lease was to be for a period of 25 years and renewable for an additional 25 years, and is subject to the lease provisions, effective upon date of approval; and

WHEREAS, Site Number 4 further described as that part of 410T0000258, being part of the Southeast Quarter of the Northwest Quarter, Section 2, Township 41 North, Range 17 West of the 4th Principal Meridian, described as follows:
Commencing at the Southwest corner of said Allotment Number 258; thence South 89 degrees 46 minutes 54 seconds East, bearing assumed, along the south line of said Allotment Number 258, a distance of 165.36 feet to the point of beginning of the land to be described; thence continue South 89 degrees 46 minutes 54 seconds East along said line South a distance of 254.74 feet; thence North 38 degrees 29 minutes 22 seconds East a distance of 126.57 feet; thence North 51 degrees 30 minutes 38 seconds West a distance of 200.00 feet; thence South 38 degrees 29 minutes 22 seconds West a distance of 284.35 feet to the point of beginning and there terminating. This lease site is 0.9 acres more or less.
