JOINT RESOLUTION 15-04-260-13

A JOINT RESOLUTION APPROVING A PROVISIONAL LICENSE TO OPERATE EARLY HEAD START, HEAD START AND CHILD CARE IN THE MILLE LACS BAND OF OJIBWE NEW CHILD CARE CENTER BUILDING IN DISTRICT I

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, according to 3 MLBSA § 2(d), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band; and
- WHEREAS, the Chief Executive is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Band Assembly acknowledges that a statutory amendment regarding the licensing of child care centers on Band Lands has been adopted by the Band Assembly on October 1, 2013 and such Bill is numbered 15-04-49-13; and
- WHEREAS, that the Mille Lacs Band child care center in District I had a provisional license adopted via Joint Resolution 15-03-231-13 and such provisional license expired on September 30, 2013; and
- WHEREAS, that Early Head Start, Head Start and the child care program needs a provisional license to operate the child care center beginning October 1, 2013 and a license from the Band is required; and
- WHEREAS, the Band Assembly and Chief Executive now approve of a provisional license for a period of one year to allow Early Head Start, Head Start, and the child care center in the new child care center building to operate during this period of time beginning on October 1, 2013.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Ojibwe hereby approves the provisional license for a period of one year beginning on October 1, 2013 for the operation of a child care center, Early Head Start, and Head Start, in the new child care center building in District I.


