RESOLUTION 15-04-244-13

A RESOLUTION MODIFYING RESOLUTIONS # 06-01-92-94 & 05-04-11-94 WHICH AUTHORIZED LAND LEASES FOR RESIDENTIAL PURPOSES TO MILLE LACS RESERVATION HOUSING AUTHORITY
(Land description 15-Pine County)

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolution # 06-01-92-94 & 05-04-11-4 authorized a land lease to the Mille Lacs Reservation Housing Authority for the purpose of establishing home sites; and
- WHEREAS, the lease is for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective May 24, 1994 for the property described herein; and
- WHEREAS, Removal of land description 15 is requested from Resolutions #06-01-92-94 & 05-04-11-94; and
- WHEREAS, Land description 15 is described as follows:
That part of the SW ¼ of the SW ¼ of the SW ¼ of Section 2, Township 41N, Range 17W, (West part of Ogema Twp.), Pine County, State of Minnesota beginning at the SW corner of Lot 1, thence East 230' to the point of beginning, thence East 200', thence North 200', thence West 200', thence 200' South to the point of beginning, known as Lot 2; and
- WHEREAS, removal of lease description 15 described above from Resolution # 06-01-92-94 & 05-04-11-94 is due to the Mille Lacs Reservation Housing Authority transferring the leasesite into [REDACTED] name for private ownership.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby Authorizes modification of Resolution # 06-01-92-94 & 05-04-11-94, by removing lease description 15 described above and all other terms and conditions shall remain the same.


