
**A RESOLUTION IN SUPPORT OF THE A TWO (2) YEAR
APPOINTMENT OF CRAIG HANSEN AS TRIBAL EMPLOYMENT
RIGHTS OFFICE (TERO) REPRESENTATIVE OF THE GREAT LAKES
REGION**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly acknowledges the excellent work that Craig Hansen provides to the Mille Lacs Band of Ojibwe Government as its TERO officer; and
- WHEREAS, Craig Hansen has held the Chairperson position since July 2012; and
- WHEREAS, the Great Lakes Region TERO now is considering new officers and requires a resolution of support supporting the appointment of a Tribal TERO representative to the Council; and
- WHEREAS, the Band Assembly continues support the appointment of TERO Director Craig Hansen to an officer position with the Great Lakes Region TERO Council for a two (2) year appointment.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Ojibwe continues support and endorses the appointment of Craig Hansen as an officer with the Great Lakes Region TERO Council for a two (2) year appointment.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 10th of September, 2013 at Isle, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
