A RESOLUTION TO ACT AS FISCAL SPONSOR FOR CHERYL MINNEMA'S APPLICATION TO THE FY 2014 "ARTS LEARNING" GRANT OF THE MINNESOTA STATE ARTS BOARD

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, the Band Assembly is authorized under 3 MLBSA sec. 2(d) to adopt resolutions in order to promote the general welfare of the people of the Mille Lacs Band of Ojibwe; and

WHEREAS, Cheryl K. Minnema, a Mille Lacs Band member, applied for a FY 2014 Arts Learning grant with the Minnesota State Arts Board as an individual artist which requires a fiscal sponsor; and

WHEREAS, the Band Assembly agrees to act as fiscal sponsor for Cheryl K. Minnema as an individual artist applying for a FY 2014 Arts Learning grant to the Minnesota State Arts Board.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly hereby agrees to act as the fiscal sponsor for Cheryl K. Minnema who is applying as an individual artist for a FY 2014 Arts Learning grant to the Minnesota State Arts Board.
