**RESOLUTION 15-03-233-13**

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY RESOLUTIONS #05-03-88-93 & 02-02-57-87 FOR [REDACTED]**

- WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and
- WHEREAS, Resolutions #05-03-88-93 & 02-02-57-87, authorized a lease to be given to [REDACTED] for the purpose of obtaining a leasesite; and
- WHEREAS, the land lease was for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and
- WHEREAS, said land is described as follows:

Part of Tract 410T000045 located in that part of the Northeast quarter of the Northwest quarter (NE1/4NW1/4) of Section Twenty-eight (28), Township Forty-three North (T43N), Range Twenty-seven West (R27W), in Vineland Hills Addition, Mille Lacs Reservation, Kathio Township, Mille Lacs County, State of Minnesota. Beginning at the NW corner of Allotment A-45, Continue South 235.03 feet, thence East 257.41 feet, thence North 235.03 feet, thence West 257.41 feet to the point of beginning. Except a small parcel of land in the SW corner in the above described lot, which is to be considered an easement on West side road. Fourth Principal Meridian. This lease site is 1 acre more or less.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves the cancellation of the land lease authorized by Band Resolutions #05-03-88-93 & 02-02-57-87; and

BE IT FURTHER RESOLVED, that the land will revert to the Mille Lacs Band of Ojibwe for lease to another Band member.
