JOINT RESOLUTION 15-02-04-13

A JOINT RESOLUTION APPROVING AN AGREEMENT FOR MEMBERSHIP IN THE NORTHEAST MINNESOTA REGIONAL RADIO BOARD.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and
- WHEREAS, the Band Assembly acting pursuant to 3 MLBSA § 2 has the authority to enact laws which promote the general welfare of the Mille Lacs Band of Ojibwe (MLBO); and
- WHEREAS, the Chief Executive of the Band is empowered to exercise the Executive Branch powers of the Band; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have established as a priority the improvement of the physical, social, and mental well-being of their Communities; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive recognize a need to provide for interoperable communications to enhance and provide for public safety and health operations; and
- WHEREAS, the Northeast Minnesota Regional Radio Board, a Minnesota Joint Powers entity, is engaged in providing interoperable public safety communications throughout Northeast Minnesota; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive are committed to participate in regional communications planning activities and have planned, authorized, developed or implemented a local sub-system or have provided equipment and services intended to provide interoperability with parties to the Agreement forming the Northeast Regional Radio Board; and
- WHEREAS, the Mille Lacs Band Assembly and Chief Executive have reviewed the Agreement forming the Northeast Minnesota Regional Radio Board and desires to participate as a member of the Agreement; and
- WHEREAS, the Mille Lacs Band of Ojibwe has applied for and has been approved for membership in the Northeast Minnesota Regional Radio Board; and

- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 25th day of October, 2012 at Isle, Minnesota by a vote of <u>2</u> FOR, <u>0</u> AGAINST, <u>0</u> SILENT.
