RESOLUTION 15-03-216-13

A RESOLUTION MODIFYING RESOLUTION #28-83 WHICH AUTHORIZED LAND LEASES FOR RESIDENTIAL PURPOSES TO MILLE LACS RESERVATION HOUSING AUTHORITY FOR THE MUTUAL HELP HOME LOANS (Tract 410T001002- Lot eight (8), Block Three (3) Vineland Hills)

WHEREAS, the Mille Lacs Band Assembly is the duly-elected governing body of the Mille Lacs Band of Ojibwe, a federally-recognized Indian Tribe; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band of Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Resolution #28-83 which authorized a land lease to the Mille Lacs Reservation Housing Authority for the purpose of establishing the Mutual Help Home Loan; and

WHEREAS, the lease included the lease site described below to be leased for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective June 29, 1987; and

WHEREAS, the Lease site is described as follows:
That part of Tract 410T001002 located in the North half of the Northeast Quarter of Section Twenty-eight (28), Township Forty-three North (43N), Range Twenty-Seven West (27W), Mille Lacs County, Minnesota. Fourth Principal Meridian,

Further described as:
Lot eight (8), Block Three (3) Vineland Hills, Surveyed by Okerman Surveying Inc., June 23, 1983.

WHEREAS, removal of the lease site above from Resolution #28-83 is being requested by MLBHD because Ms Beverly Garbow has paid in full her Mutual Help loan in full. and

WHEREAS, the home located on the lease site is a private home and the lease site should be under the name of the owner.
